

REPUBLIC SERVICES CONTRACT 2020-2022

Our agreement with Republic Services ends on 12/31/2019. We have negotiated a new contract with Republic starting 1/1/2020. Here are the highlights of that contract:

- 1. The price would be basically the same for the next 3 years, but it is structured somewhat differently than the current contract.
- 2. The rates the first two years would be slightly less than what we are paying now. It would be \$15.50/mo. the 1st year and \$16.59/mo. the 2nd year. The 3nd year would be \$17.75/mo. This is calculated by factoring in a 7% increase for year 2 and then another 7% for year 3. Previously, under the old contract the rate increases were 5% for year 2 and another 5% for year 3.
- 3. Billing would be quarterly to each individual homeowner, as is being done now. The new contract basically keeps the overall total costs for 3 years virtually the same as the old contract.

All other terms of the old contract would apply to the new one, including the availability of vacation holds for 1 to 9 months. We would continue our twice/week trash pickup and once/week recycling pickup.

ADDRESS LIGHT MAINTENANCE: IMPORTANT CHANGE!

Your Light Bulb Committee has been hard at work replacing burned out bulbs with new LED bulbs. Since changing from incandescent, bulbs are lasting much longer and using less electricity. This has saved our HOA money and given our light bulb committee more free time.

We are now taking steps to improve efficiency and save homeowners money and time. We are beginning to use LED bulbs which have sensors in them. They are called Dusk to Dawn bulbs because the built-in sensor causes the bulbs to go on at dusk and then off at dawn. We have been monitoring their performance on a few houses on a trial basis, and they seem to work very well.

We now have a small supply of Dusk to Dawn bulbs, and will purchase only these when our supply of regular LEDs is used up. YOU WILL NEVER HAVE TO REPLACE THE SENSOR ON YOUR ELECTRIC BOX AGAIN! If you notice that it is not functioning (ie. your light is shining for hours during the day) please notify a light bulb committee member and you will be provided with a Dusk to Dawn bulb right away.

Be Safe... "Sheriffs Auxiliary Volunteers"

Robberies-- Happen Everywhere!

Really? Well, yes, there have been some 'break in' concerns this summer. And, as with most things, an ounce of prevention is worth a pound of cure.

SAV is an excellent resource for specific tips for snowbirds and yearly residents.

- 1. **Plan** for departure whether short or long. Lock up. If appropriate, notify the SAV, your block captain, and your neighbors.
- 2. Have a **plan** for longer absences. Give someone information about how to reach you if there is a problem. Let them know your return schedule. Stop services like newspapers so they don't accumulate.
- 3. **Plan** for your return. Inspect your property before entering. Have a list of "to-do" if you or a neighbor see a problem. Know numbers to call.

All of these are good suggestions, but working with your neighbors is your best route to keeping your home safe. Don't know your neighbors? Well, start introducing yourself and be prepared to return the house-watching favor.

Easy access to you or your paid home-watchers, while you are gone, ensures that your **plan** can be initiated when there is a problem.

Know your stuff and inventory your valuables. Store appropriately.

We all want trouble-free trips away, whether short or long. Prevention is your best burglary attempt option. Stay safe and help your neighbors to stay safe as well.

The Springs Street Projects for 2019

Three projects were slated for completion in 2019 according to Lee Blahnik, The Springs' Streets, Buildings & Utilities Chairperson.

The first project was the removal and replacement of a caved section of sidewalk on the northeast side of the Golfista "bridge" that spans the wash. Now complete, the most difficult portion of the project was determining the cause of the problem. As you might expect, the culprit was erosion and a 4 foot wall is now in place to stabilize the area in addition to new sidewalk panels.

The second and most ambitious project of 2019 was the removal and replacement of asphalt on the entire length of Calle de la Pelotita. Like several streets to the south of Fuerte (which were replaced in 2013 due to deteriorating asphalt), Pelotita was identified as needing replacement in 2019. Milling asphalt involves removal of a predetermined thickness of the existing road (in this case three inches). Paving the road with new asphalt was scheduled for early September. However, it was determined, once some asphalt was removed, that the base bed of Pelotita also needed removal and replacement. This caused a delay in the completion of the project, but failure to repair properly would have only caused more problems.

A subcontractor completed the base work with special equipment in late September after the rain subsided, and asphalt was replaced by Sunland Construction in early October.

The scope of the Pelotita project was significant and required creative communication to residents as well as stakeholders like USPS, Republic Services, Fed EX, UPS and the Fire Department. Eblasts, phone calls, notices on bulletin boards, and plain old face-to-face communication were used by Lee to keep affected residents up to date with the changes in the project. Thanks to everyone for their patience. We realize there was inconvenience but Lee and his volunteers did the best they could, with admirable results. Many folks have expressed their gratitude for the efforts that were made to communicate with them about the project.

At the present time, street sweepers are cleaning around the area of Pelotita repair, and manhole covers are being placed back in position.

The third project, "crack seal," is yet to be completed. Damage to our streets can occur when water intrudes through cracks in the asphalt. Crack filling is an essential application, in addition to sealcoating for long-term pavement protection. As a rule, crack seal of our streets is done every other year. This is followed by seal coating which covers the entire surface (not just the cracks) in 2020. The contractor plans to do the work around November 11, weather permitting, as the work is best done when there are not extreme temperatures.

Those are the three projects for 2019. Your friendly Cap Reserve and Finance committees are currently working with the Board to plan for 2020. The new street projects will be announced in December.

We Are Continuing

We are continuing the process of getting GVR to help pay for road repairs of The Springs' streets heavily used by GVR patrons. We hope to document patron use of our roads as the winter folks come and also monitor frequency of garbage collection and other large trucks at our GVR site, so the percent of non-residents arriving at the Springs daily is accurate.

Currently there is planning and discussion about a section of Fuerte for removal and replacement of asphalt in 2020. The latest information from Sunland has reconstruction on Fuerte starting at the Fuerte/Heroe "fork" (GVR sign) and stopping just before Golfista. This will leave a route for traffic to use Heroe to connect with Golfista and access the north side of the Springs. The project time, with good weather, would be about a one week duration.

A future project would address repaving Fuerte from the frontage road to the Fuerte/Heroe fork with each lane being done in stages.

For now we are going to concentrate on GVR for the first phase. We want \$\$\$ to help pay for repaving, and also help to organize a successful project so that information distribution, parking plans and possibly even a short closure of the GVR site can help the project succeed.

If we succeed, then we hope to use the plan for the next phase of Fuerte.

NEIGHBORHOOD CHAIN OF SURVIVAL (NCOS) PROJECT FOR THE SPRINGS AT SANTA RITA "Info from Heartsafe now known as NCOS"

Our community has partnered with the Community Foundation of Southern Arizona to establish a local neighborhood volunteer network to expedite a lifesaving response when a neighbor experiences a sudden cardiac arrest. Victims of sudden cardiac arrest in a residential neighborhood are more likely to survive when CPR is begun within minutes of the event and an AED is used as quickly as possible, often by a good Samaritan bystander.

A group of residents of the Springs have volunteered to receive CPR and automatic external defibrillator (AED) training and respond quickly when alerted to a sudden cardiac arrest emergency at an address in our community. Here is how the program works:

- 1. A witness to the emergency will call 911 and report that the victim is unconscious and appears to have stopped breathing, the first signs of sudden cardiac arrest.
- 2. In a medical emergency, the 911 operator will pass the alert to a medical operator who will collect more information and alert the nearest fire station/EMS facility to respond.
- 3. The NCOS system will also be alerted to emergencies in The Springs and pass on alerts to all our community volunteers via cell phone, text message, and land line.
- 4. Volunteers in the immediate area will travel safely to the address of the emergency and begin CPR and use an AED until professional responders arrive.

You may remember that a study conducted the summer of 2018 in The Springs by the University of Arizona/Sarver Heart Center and the Green Valley Fire Department demonstrated that volunteers could arrive critical minutes before professionals from the nearest fire station. Other studies indicate a much higher survival rate from such a quick response. Arizona and Federal Good Samaritan laws protect the responding volunteers.

AEDs will be placed in a central location in the community in weatherproof cabinets for use by volunteers in an emergency. Also, signage announcing The Springs as a HeartSafe Community will be placed at the entrance to our development. We are the first such community in Green Valley and Tucson.
