THE SPRINGS BOARD OF DIRECTORS MEETING 9 February 2004

Architectural Review -

MOTION: Made and seconded to buy four "for sale by owner/open house" signs for not more than \$400, to be used by residents of The Springs, providing they pay a \$100 deposit. Motion passed.

THE SPRINGS BOARD OF DIRECTORS MEETING 1 March 2004

Streets and Buildings -

MOTION: To give the committee authorization to install a speed bump by the gate house to provide increased safety for people going to the HOA office and to do whatever is necessary with the existing speed bumps. Motion passed.

Lee presented an HOA Street and Sidewalk Use Policy for consideration by the board. It calls for homeowner responsibility for the area in front of their home when having landscaping or remodeling work done.

MOTION: Made and seconded to accept the Street and Sidewalk Use Policy as written to be added to the CC&Rs. Motion passed.

Lee also presented a revised CC&R Rules Enforcement Policy that was passed by the prior board. The following items were added or changed: In Step One: A copy of the letter will be provided to each board member, preferably by e-mail. The HOA office address and phone number shall be included in the letter for the homeowner to respond to if they wish. In Step Two: Policy should also state that the Warning letter will be sent by certified mail, not registered mail, with a signature required. In Step Three: the Policy should say the letter that describes legal action will also be sent by certified mail, not registered mail. Both Step Two and Step Three also include the e-mail notification and address and phone number clauses as stated in Step One.

MOTION: Made and seconded to accept these revised Policy changes. Motion passed.

MOTION: Made and seconded to allocate \$2,000 for a new computer and software for the HOA office. Motion passed.

THE SPRINGS BOARD OF DIRECTORS MEETING 3 May 2004

MOTION: Lee Huey made a motion to pay up to \$3,000 to pave the entrance to the park off of Wolf Run Road. Ron Shaffer seconded the motion. Motion was approved.

THE SPRINGS BOARD OF DIRECTORS MEETING June 22, 2004

MOTION: Mr. Kearns moved, seconded by Mr. Huey to have Mr. Honmyhr proceed with the Association Reserves proposal and get the study scheduled with the cost of \$1710 and the 8 week turnaround option. This was the least expensive option. Motion carried.

Amend Parking Policy – Tom Honmyhr-- An amended parking policy was presented.

MOTION: Paul Walter made a motion, seconded by Mike Kearns, to approve the amended policy. The motion passed.

CC&R Rules Enforcement Policy – Tom Honmyhr--An amended rules and enforcement policy was presented.

MOTION: Paul Walter made a motion, seconded by Connie Fish, to approve the amended policy. The motion passed.

Reimbursement Policy – Tom Honmyhr-- A Springs Administrative Reimbursement Policy was presented.

MOTION: Paul Walter made a motion, seconded by Mike Kearns, to approve the policy. The motion passed.

The Springs Private Property Tree Policy was presented.

MOTION: Paul Walter made a motion, seconded by Ron Shaffer, to approve the policy. There was discussion on the policy. Tom Honmyhr suggested that we table the motion until the next board meeting. The board members agreed.

THE SPRINGS BOARD OF DIRECTORS MEETING November 16, 2004

Reserve Study - Paul Walter explained the modifications that were done to the reserve study. Some items were moved to the budget, other items had decreased costs or increased life and other items were deleted. Because of these modifications the HOA is 48% funded instead of the 27% that was projected from the original reserve study. He discussed the HOA Reserve Components for 2005.

MOTION: Made by Gene McGaughey and seconded by Ron Shaffer to implement the reserve study done by Association Reserves Arizona, LLC.

THE SPRINGS BOARD OF DIRECTORS MEETING February 7, 2005

MOTION was made by Mike Kearns, and seconded, to accept the bid of Wiese Painting Contractors for \$15,289.00. This includes repair, new caps, paint, clean up, traffic control plus painting the entry gate and fence, fountain, and under the roof; all with a 3-year guarantee. Paul Walter suggested the figure be raised to \$15,500 to cover contingencies. The motion to accept the bid and allot \$15,500 was approved.

Richard Olson asked about seal coating the new access path at the south end of the park. After some discussion,

MOTION by Ron Shaffer, which was seconded, to authorize \$100 to get material to seal the walk. During discussion, it was amended to raise the amount to \$200. The motion was approved as amended.

THE SPRINGS BOARD OF DIRECTORS MEETING March 7, 2005

Treasurer's Report: **MOTION** by Paul Walter: "Any new, non-recurring expense exceeding \$250 must be approved by the HOA Board." Motion carried.

Grass Park Conversion:

MOTION by Paul Walter: "We accept the proposal of the Committee and ask it continue the work to convert the 3 areas to desert landscaping." He said it would be within the tolerance of the budget. There was discussion about specific

design details, i.e. providing mounds, cacti, paths, and it was agreed that this would be done as soon as possible. Doug Kile asked that the rock be a muted, darker shade. Motion carried.

HOA Insurance Coverage: Joe Barton gave a report on HOA insurance coverage. The By-laws and CC&R's have been reviewed and it was found we are not in compliance (see attached). We will need to amend the By-laws and make adjustments to our insurance package. Workers Comp is recommended for our Gardener and Office Manager. The CC&R's require a Fidelity bond. To summarize, it may mean an additional \$1,000 a year

MOTION by Paul Walter: "We accept these recommendations of the Insurance Committee and enable them to move forward on the insurance requirements." Motion carried.

THE SPRINGS BOARD OF DIRECTORS MEETING April 4, 2005

Gene McGaughey presented the Board with a proposed generic letter (attached) to become the standard format to be used when informing homeowners that changes are required to conform with the CC&R's. Mike Kearns suggested that 14 days be the response time for weed problems.

MOTION by Paul Walter: The Board will use this form letter when enacting enforcement policies in the CC&R's for all violation notices. Motion carried.

MOTION by Paul Walter: A quarterly inspection will be made of the Springs to identify violations of the CC&R's. Motion passed.

MOTION by Richard Olsen: The Springs policy will be that we have our park path be for walking only, no bicycles or roller blades, and signs will be posted at each entrance." Motion passed.

MOTION by Paul Walter: It is the Springs policy that the Picnic Park is not to be used as an area for animals to relieve themselves. Motion passed.

THE SPRINGS BOARD OF DIRECTORS MEETING May 2, 2005

MOTION by Floyd Parker on the changes in the By-Laws re definition of a quorum: "The Board of Directors approve these documents to be sent out on June 1 for resolution on June 29" Motion was seconded and passed.

MOTION by Paul Walter to install a "No Dumping" sign near the dumpster. Motion was seconded and passed.

A sample of the second generic letter to be sent out to homeowners who are violating the CC&R's was reviewed. Gene McGaughey explained the need and asked that this letter to be approved. It was suggested that we add the wording, "plus a service fee" to the sentence ending with "forward the cost to you."

MOTION by Paul Walter: "To accept the second letter as amended."

Cindy Misiewicz suggested that we include a picture of the violation with the second letter.

AMENDMENT TO THE MOTION by Paul Walter

"We include a picture of the violation with the second letter." Both the Motion and the Amendment to the Motion were seconded and approved.

MOTION by Mike Kearns:

"Remove the speed bumps at the entrance to the Springs." Motion was seconded and passed.

MOTION: by Paul Walter and seconded by Floyd Parker to table the discussion of the tree policy until next month. Motion passed.

Light Bulb – The following is the policy change: Address fixtures are to be illuminated. A group of HOA volunteers are checking for burned out bulbs and replacing them. Only 25 watt yellow bug lights are to be used. Contact the HOA office or light bulb replacement chairman if a light bulb is burned out. Defective light fixtures are the responsibility of the homeowners and must be promptly repaired.

MOTION: by Paul Walter and seconded by Mike Kearns to approve the light bulb policy change. Motion passed.

MOTION: by Ron Shaffer to rescind the motion that was passed to remove the speed bumps. Floyd Parker seconded this new motion and it passed.

The Springs Board of Directors Meeting September 5, 2005

MOTION by Mike Kearns: Flagpole length shall not exceed 6 feet and can only be displayed above the garage door or in the entryway. Flagpoles on portable platforms or on concrete pads in yards are not permitted. Motion passed.

The Springs Board of Directors Meeting October 3, 2005

MOTION by Floyd Parker: It shall be the policy of The Springs Homeowners Association that no individual or committee shall exceed a previously approved budget amount, nor expend or obligate funds that have not been budgeted without the prior approval of the Homeowners Association Board of Directors at a regular meeting of the Board, or at a special meeting of the Board called for that purpose. There was discussion about the need for flexibility within the budget. Motion passed.
