Highlights From Your May 12 HOA Board Meeting

The meeting was held in the Anza Room following the hybrid format. The meeting was called to order with 21 homeowners present. Roll was called and a quorum was established.

Board member reports were presented and can be found in their entirety on the HOA web site, www.thespringshoa.org for your review. A brief synopsis follows.

- President: It was a busy as well as productive month. Finally resolved the issue of Republic emptying the wrong dumpster; or so it seems. Thanks to the diligence of Sharon Toborg on this task, three weeks in a row they have emptied the correct one. Responded to resident concerns. Worked with Victor installing new pet waste/leash law signs and speed limit signs. Went door to door making affected residents aware of paving dates. New flashing speed detection signs will be placed as a beta project for information gathering. They will be placed again once the snowbirds return.
- Vice President: Continues to becoming familiar with the CC&Rs and interacting with residents and other board members. Will be available for grant writing.
- Treasurer:

- ARC: 4 new requests were submitted for approval. Compliance Agent reports that 7 of the 45 maintenance violations issued on April 1 have been corrected in a timely manner. Six 2nd violation notices were issued and will be reinspected in June. Yard notices are being addressed timely with one being challenged.
- Grounds: There have been 840 total volunteer hours worked through the end of April 2024. The snowbirds have returned to their respective summer homes and the available volunteers have been drastically reduced. This is such a valuable service that these individuals provide. - Infrastructure: Arizona Painting has completed the bell tower, gate house, and frontage road wall project. Tucson Asphalt will be resealing the south end roads that did not receive new paving in the last project. Scheduled May 14-17. Please make arrangements for this small imposition that will preserve our streets for years to come. Over the summer months you can expect to see new "SLOW" and "STOP" signs painted on the pavement in strategic areas along with the addition of disc bumps installed as a reminder to watch your speed through The Springs. A beehive was relocated with the assistance and expertise of Mark Koruga. Monthly AED inspections are current and in good working order.

In new business, a motion was made to have the board meetings "go dark" during the months of June through August, as is customary. In September the ARC will present a new Paint Guidelines for board approval. It is proposed that there be twelve colors available for doors and screen/security doors as opposed to just the current five. Board approved additional \$400 for social committee expenses.

From the President

Here we go! Summertime, 100 degree days, monsoon season, and a couple more small road projects, while we have less traffic, that will be completed by volunteers. It's also a time when the Board will not be meeting unless there is a need for a Special Meeting, which would be announced, by e-blast, at least 10 days prior to the date. During our summer hiatus we will be working on Grounds projects, Infrastructure projects, ARC issues, and policy reviews of a few topics on which we will keep you informed.



I attended the May, Green Valley Council Board of Representatives meeting as an interested bystander, and the Green Valley Council Monthly President to President Roundtable. I'd like to share a few items that came out of those meetings:

- There has been a continuing issue with predatory scams throughout Green Valley (and everywhere else in the country!). Here is a condensed list of ways you can help yourself avoid or stop a possible scam:
 - If using a contractor for any work, check them out on the Better Business Bureau website and the Arizona Registrar of Corporations website prior to contracting them.
 - If you are feeling pressured to commit to a project, ask them for references and say that you will check them. One recent contractor soliciting in The Springs was telling folks he had the president's ok. Too bad he didn't knock on my door!
 - If you enter into any contractual agreement, Arizona state law has a 3 day "cooling off" provision whereby you can cancel any contractual agreement within 3 days with no further obligation and receive back any deposit money.

- If you have a "No Soliciting" sign on your door, it is unlawful for a vendor to knock or ring the doorbell. Unfortunately, the "No Soliciting" sign at the front gate does not provide that protection.
- If you buy items from online vendors (who doesn't?), it is better to use a thirdparty payment service like PayPal. That way the vendor never sees your credit or debit card numbers. And don't use debit cards! They are generally attached to your cash accounts.

A couple other pieces of information that I learned from the Presidents' Roundtable include:

- Arivaca Road is being repaved from June 3 to June 28. You'll experience delays and/or closures during that time.
- If you visit the Green Valley Council website www.gvcouncil.org you can register for a Community Portal which allows all homeowners to stay informed about all the services, project, legislative changes, and activities of the GVC. There will be no solicitations or list sharing by the GVC.
